## From the CSTC President Digital Assets

I recently read an article about digital assets. We've encountered digital assets before with cryptocurrency. The IRS defines digital assets as "any digital representation of value which is recorded on a cryptographically secured distributed ledger or any similar technology." Its examples include cryptocurrency, stable coins, and non-fungible tokens (NFTs).

But the article I was reading was not about tax, but about estate planning. In that realm, the term digital assets has a much broader definition. It includes all your online accounts and hard storage devices. So I made a mental list. My digital assets would include hard storage devices – desktop, laptop, and external hard drive – and online accounts – email accounts, social media accounts, and my website.

It does indeed include all of these, but it includes much more: cloud storage, such as Google Drive and Apple iCloud, and online financial accounts, such as online bank accounts and PayPal. It also includes blogs, picture and document storage, music, video, and gaming accounts and purchases, subscription services, manuscripts and computer files, shopping and reward programs, and even recipes stored online!

A few years ago, I made a list of relevant information for my kids to have when I'm gone or incapacitated, and I uploaded it to their secure portals. It includes passwords, security questions, and other information they may need. But I was surprised when I saw the above list of digital assets, and saw how much was included. My password manager includes access to most of my online and storage accounts, but I need to go through it to see that everything is included.

Some suggest keeping this list in a sealed envelope separate from your will or trust documents. And that the will or estate documents should contain a specific clause to allow your executor to access some or all of the digital assets. This involves legal issues, and therefore should be discussed with the attorney helping with your estate planning.

But listing one's digital assets and access information, and defining who has access is something we individually need to do. My year-end review this year is definitely going to include a vetting and an update of my list of digital assets and related information!



Syndicated conservation easements have been included in the IRS' annual list of Dirty Dozen tax schemes for many years.
