# From the CSTC President

There has been a lot of buzz lately about the activities at the IRS and the impact it may have on this tax season and beyond. I'm not trying to get political here (if you want that you can buy me a drink the next time you see me), but I do think that there is a pretty good chance this will cause some additional stress for us this year. Processing may be delayed, which means that taxpayers will be calling us to see where their refunds are. Practitioner Priority wait times may be longer and it will likely be more difficult to assist our clients in resolving issues. Right now, our best weapon might be patience.

#### BOI is Back, baby! (Well, sort of)

I hesitate to even write this, considering the whiplash-inducing amount of back-and-forth there has been on this issue, but after several injunctions and stays, as of February 19, 2025 Beneficial Ownership Reporting is once again mandatory. For most companies, reports must be filed by March 21, 2025. You can find the most up-to-date information on the <u>FinCEN</u> website.

\*UPDATE – Since writing this on the 26th, FinCEN released Notice FIN-2025-CTA2 indicating that despite the March 21st

deadline, they will not issue any fines or penalties or take any other enforcement action based on failure to file or update reports until they issue an interim final rule.

So, the question continues to be: "to B(OI) or not to B(OI)?"

Are you taking advantage of the CSTC Member Listserv?

Tax documents added to IRS Individual Online Account tool, enhancing services and convenience for taxpayers

IR-2025-28, Feb. 27, 2025 — The Internal Revenue Service announced today it's making it easier for taxpayers to file their taxes by adding information return documents to their IRS Individual Online Account, helping consolidate important tax records into one digital location.

IRS: Many farmers and fishers face March 3 tax deadline; disaster areas have more time

IR-2025-27, Feb. 27, 2025 — The Internal Revenue Service today reminded farmers and fishers who chose to forgo making estimated tax payments by January that they must generally file their 2024 federal income tax return and pay all taxes due by March 3, 2025.
